RESOLUTION NO-SP 1614, S-2001

A RESOLUTION RATIFYING THE CONTRACT ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT THROUGH THE CITY ASSESSOR'S OFFICE REPRESENTED BY THE HONORABLE MAYOR ISMAEL A. MATHAY, JR., AND THE A & J BUSINESS VENTURES REPRESENTED BY ITS PROPRIETRESS, MS. CAROLINA D. CASTILLO, FOR THE PROPOSED INSTALLATION OF UNINTERRUPTED POWER SYSTEM, AIRCON UNIT AND BUNDY CLOCKS AT THE CITY ASSESSOR'S OFFICE IN THE AMOUNT OF FOUR HUNDRED SIXTY-EIGHT THOUSAND PESOS (P468,000.00)

WHEREAS, on the 22nd day of August 2000, the Quezon City Government through the City Assessor's Office represented by the Honorable Mayor Ismael A. Mathay, Jr., and the A & J Business Ventures represented by its Proprietress Ms. Carolina D. Castillo entered into a contract for proposed installation of uninterrupted power system, aircon unit and bundy clocks at the City Assessor's Office in the amount of Four Hundred Sixty-Eight Thousand Pesos (P468,000.00) as evidenced by a copy of said contract hereto attached as Annex "A" to form an integral part hereof;

WHEREAS, it appearing that the said Contract is regular in all respect, thus, the same may be ratified by the City Council.


