RESOLUTION NO.-SP-1616, S-2001

A RESOLUTION PRESENTING A POSTHUMOUS AWARD TO THE LATE ASSEMBLYMAN NARCISO RAMOS WHO SPONSORED THE AMENDMENT OF COMMONWEALTH ACT NO. 502 IN THE NATIONAL ASSEMBLY ON OCTOBER 12, 1939 FOR THE CREATION OF QUEZON CITY FROM THE PROPOSED BALINTAWAK CITY AND IN HONOR OF HIS CENTENNIAL ANNIVERSARY ON NOVEMBER 11, 2000.

WHEREAS, in line with Mayor Ismael A. Mathay, Jr's Historical and Nationalism Development Program for Quezon City, and on the occasion of the City's 61st Foundation Anniversary on October 12, 2000 it is but fitting to give due recognition to the late Assemblyman Narciso Ramos for his great achievement in amending Commonwealth Act No. 502 before the National Assembly on October 12, 1939 that paved the way for the creation of Quezon City from the original proposal Balintawak City;

WHEREAS, it is likewise proper that the present generation of Quezon City residents, especially on the celebration of his centennial anniversary in November 11, 2000, be informed of the above City, in order to galvanize their social awareness, sense of nationalism and dignity;

WHEREAS, valuable contributions made of the venerable statesman Narciso Ramos to our city's historical development should be given proper recognition by presenting thru his descendant former President Fidel V. Ramos a posthumous award,

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to present, as it does hereby present, a posthumous award to the late Assemblyman Narciso Ramos, who sponsored the amendment of Commonwealth Act No. 502 in the National Assembly on October 12, 1939 for the creation of Quezon City from the proposed Balintawak City and in honor of his Centennial Anniversary on November 11, 2000.
