RESOLUTION NO. SP-1617, S-2001

A RESOLUTION RATIFYING THE CONTRACT ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT THROUGH THE CITY HEALTH DEPARTMENT REPRESENTED BY THE HONORABLE MAYOR ISMAEL A. MATHAY, JR. AND A&J BUSINESS VENTURES REPRESENTED BY ITS PROPRIETRESS, MS. CAROLINA D. CASTILLO, FOR THE PROPOSED REPAIR AND IMPROVEMENT OF FRISCO HEALTH CENTER LOCATED AT SAN FRANCISCO DEL MONTE, QUEZON CITY, IN THE AMOUNT OF TWO HUNDRED NINETY EIGHT THOUSAND PESOS (P298,000.00)

WHEREAS, on the 6<sup>th</sup> day of November 2000, the Quezon City government through the City Health Department, represented by His Honor, Mayor Ismael A. Mathay, Jr., and the A&J Business Ventures, represented by Ms. Carolina D. Castillo in her capacity as proprietress, entered into a contract for the repair and improvement of Frisco Health Center located at San Francisco Del Monte, this City, in the amount of Two Hundred Ninety Eight Thousand Pesos (P298,000.00) as evidenced by a copy of said contract hereto attached as Annex "A" to form an integral part hereof,

WHEREAS, it appearing that the said contract is regular in all respect, thus, the same may be ratified by the City Council.

Castillo, for the proposed repair and improvement of Frisco Health Center located at San Francisco Del Monte, this City, in the amount of Two Hundred Ninety-Eight Thousand Pesos (P298,000.00)
