A RESOLUTION RATIFYING THE DECISION OF THE HONORABLE CITY MAYOR ISMAEL A. MATHAY, JR., TO CAUSE THE RECONSTRUCTION OF THE QUEZON CITY BOY SCOUTS BUILDING AT THE QUEZON CITY HIGH SCHOOL COMPOUND.

Introduced by Councilors GODOFREDO T. LIBAN II, EUFEMIO C. LAGUMBAY, JORGE L. BANAL, RAMON G. MATHAY, BAYANI V. HIPOL, ELIZABETH A. DELARMENTE, JESUS C. SUNTAY, ANTHONY C. CASTELO, and MA. FRESCA M. BIGLANG-AWA.

WHEREAS, the Boy Scouts of the Philippines (BSP) Quezon City Council, has requested the Honorable City Mayor Ismael A. Mathay, Jr. for assistance in the reconstruction of the Boy Scouts Building at the Quezon City High School Compound;

WHEREAS, the Honorable City Mayor has acted favorably on the request of the Quezon City Council of the BSP and the Quezon City Government through its Pre-qualification Bids and Awards Committee (PBAC) per Resolution No. 01-112 awarding the project contract to ISH Construction in the amount of Seven Million Two Hundred Thirty-One Thousand Three Hundred Twenty Seven Pesos and 72/100 Centavos (P7,231,327.72);

WHEREAS, the BSP Quezon City Council Headquarters and service center was constructed and donated by then President Diosdado Macapagal in June of 1996;

WHEREAS, on May 13, 1997 the said Council Headquarters was partially burned as a result of a fire that gutted the Quezon City High School Building;

WHEREAS, the Quezon City Boy Scouts in particular and the Boy Scouts of the Philippines in General, a non-political, non-religious, non-commercial socio-civic organization comprising 135,000 Scouts, 2,000 Scouters and some 500 laymen and supporters of Scouting are in need of support in perpetuating scouting as a means of developing our youth as responsible citizens and community leaders and this can be best achieved by providing them with a strategically located headquarters;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the decision of the Honorable City Mayor to cause the reconstruction of the Quezon City Boy Scouts Building at the Quezon City High School Compound at Kamuning, Quezon City.
