RESOLUTION NO. SP 1621, S-2001

A RESOLUTION URGING CONGRESS TO STUDY THE POSSIBILITY OF PROVIDING HEALTH CARE BENEFITS THROUGH THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) TO ALL SENIOR CITIZENS OF THE PHILIPPINES.

WHEREAS, senior citizens composed six percent (6%), more or less, of the total population of the Philippines;

WHEREAS, senior citizens are at an age where they need assistance specifically in healthcare;

WHEREAS, some of them are not receiving pensions and other renumerations from both private and government entities and are therefore not covered by R.A. 7875 or the National Health Insurance Act of 1995.

WHEREAS, these senior citizens are either wholly dependent on their families or are left to fend for themselves;

WHEREAS, in times of sickness they cannot afford to spend for proper medical care and attention due to high cost of medicines and hospitalization;

WHEREAS, it is just right and fitting that the government shall take care of the needs of our senior citizens.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Congress to study the possibility of providing health care benefits through the Philippine Health Insurance Corporation (PHILHEALTH) to all senior citizens of the Philippines.
