RESOLUTION NO. SP 1622, S-2001

A RESOLUTION AUTHORIZING THE SALE OF THE MOTOR VEHICLES AND FURNITURE AND FIXTURES OFFICIALLY ASSIGNED TO VICE MAYOR CONNIE S. ANGELES, AT A PRICE TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE, SUBJECT TO EXISTING AUDITING RULES AND REGULATIONS.
