RESOLUTION NO. ~~SP-4624~~, S-2001

A RESOLUTION URGING HER EXCELLENCY, PRESIDENT GLORIA MACAPAGAL ARROYO, TO CONSIDER BUILDING PUBLIC HOUSES BASED ON THE PUBLIC HOUSING CONCEPT ESPECIALLY IN HIGHLY URBANIZED CITIES IN THE ENTIRE PHILIPPINES AS ONE OF HER PROJECTS AND TO ALLOCATE THE NECESSARY AMOUNT FOR ITS INITIAL IMPLEMENTATION.

WHEREAS, there is an ugent need to provide proper shelter to the people belonging to the low income group especially in highly urbanized cities in the country;

WHEREAS, socialized housing projects being undertaken by our government has not substantially addressed this need in its entirety;

WHEREAS, most people belonging to the low-income group still cannot afford to pay the minimum equity and monthly amortization of socialized housing;

WHEREAS, these people are forced to squat and live in squalor in areas not intended for residential use unmindful of the harm and danger that will befall them;

WHEREAS, a previous resolution unanimously approved by the Quezon City Council docketed as SP-1426, S-2000 also urging the president to consider building public houses was forwarded to the office of the then President Joseph Ejercito Estrada;

WHEREAS, due to the recent political turmoil experienced by our country, this resolution was not acted upon;


RESOLVED, FURTHER, to urge, as it does hereby urge, President Gloria Macapagal Arroyo to allocate the necessary amount for its initial implementation.
