RESOLUTION NO. SP <u>+ 6 2 6</u>, S-2001

A RESOLUTION GRANTING HEALTHCARE BENEFITS THROUGH THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) TO ALL THE CASUAL AND CONTRACTUAL EMPLOYEES OF THE QUEZON CITY GOVERNMENT AND APPROPRIATING THE NECESSARY AMOUNT IN THE ANNUAL BUDGET FOR THIS PURPOSE.

WHEREAS, the casual and contractual employees of Quezon City government are receiving barely above the specified minimum wage;

WHEREAS, most of them belong to the poor and marginalized sector of our society and, thus, cannot afford the prohibitive cost of hospitalization when needed;

WHEREAS, the Quezon City Government is aware of this need and shall provide for health care insurance benefit to all the casual and contractual employees of Quezon City.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, healthcare benefits through the Philippine Health Insurance Corporation (PHILHEALTH) to all the casual and contractual employees of the Quezon City government and appropriating the necessary amount in the Annual Budget for this purpose.
