A RESOLUTION STRONGLY URGING THE ONE HUNDRED FORTY-TWO (142) BARANGAYS OF QUEZON CITY TO SET ASIDE AND APPROPRIATE THE SUM OF TWO THOUSAND PESOS (P2,000.00) EVERY YEAR IN ITS ANNUAL BUDGET AS CONTRIBUTION TO THE LUPON TAGAPAMAYAPA FEDERATION.

WHEREAS, the Lupon Tagapamayapa of Quezon City have organized themselves into a federation in order to fully assist the barangays in undertaking proper, efficient and effective settlement of disputes between two (2) parties;

WHEREAS, the mission, objectives and goals of the federation are consistent with those of the barangays for the best interest of their constituents;

WHEREAS, on February 11, 2001, the Lupon Tagamapayapa Federation of the First District of Quezon City during its assembly passed Resolution No. 002, S-2001 requesting every barangay in Quezon City to appropriate/include the sum of Two Thousand Pesos (P2,000.00) as contribution to the Lupon Tagapamayapa Federation;

WHEREAS, for the district of Quezon City where Lupons have yet to form their respective federation, the amount of Two Thousand Pesos (P2,000.00) will be reverted back to the annual budget of the barangay;

WHEREAS, the City Council of Quezon City strongly supports the sentiment of the Lupon Tagapamayapa members that there is a need for barangays to set aside the amount of P2,000 in their annual budget as financial contribution to the Lupon Tagapamayapa members.
