RESOLUTION NO. SP 1628, S-2001

A RESOLUTION STRONGLY URGING ALL THE BARANGAY SECURITY AND DEVELOPMENT OFFICERS (BSDO) TO BE HEADED BY THE BSDO'S EXECUTIVE OFFICERS OF QUEZON CITY TO ORGANIZE AND FORM ONE CITY-WIDE ASSOCIATION, LEAGUE OR FEDERATION OF BARANGAY SECURITY AND DEVELOPMENT OFFICERS (BSDO's).

WHEREAS, at present, there are an estimated 2,000 Executive Officers and Barangay Security and Development Officers (BSDO's) combined in the 142 barangays comprising the four Districts of Quezon City;

WHEREAS, those occupying the position of Executive Officers and BSDO's are among the local government officials who presently do not have a national or city-wide league or association of their own formally registered with and recognized by the appropriate government agencies;

WHEREAS, an organized body of all the Executive Officers and BSDO's all over Quezon City is necessary for a more efficient delivery of their police duties;


WHEREAS, an organized body of all the Executive Officers and BSDO's of the different barangays will encourage uniformity and cooperation among them in dispensing their duties.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL IN SESSION ASSEMBLED, to urge, as it does hereby strongly urge, all the Barangay Security Development Officers (BSDO's) to be headed by the BSDO's Executive Officers of Quezon City to organize and form one city-wide association, league or federation of Barangay Security and Development Officers (BSDO's).

RESOLVED, FURTHER, that a copy of this resolution be furnished to all the Executive Officers and members of the Barangay Security and Development Officers.
