RESOLUTION NO. SP- 1 6 3 7 35-2001

A RESOLUTION STRONGLY URGING QUEZON CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO IDENTIFY FROM THE INVENTORY OF FIXED ASSETS OWNED BY THE QUEZON CITY GOVERNMENT, AN APPROPRIATE GOVERNMENT LAND TO BE UTILIZED AND MADE AVAILABLE AS SITE FOR THE ESTABLISHMENT OF A QUEZON CITY JUNK YARD.

Introduced by Councilor JANET M. MALAYA.

WHEREAS, there are many junk motor vehicles and other materials which litter the sides of public thoroughfares, roads, city and subdivision streets within the jurisdiction of Quezon City, which are ugly sights and which obstruct the free flow of vehicular traffic and pedestrian passage;

WHEREAS, there has been a long felt need for the establishment of a Quezon City Junk Yard, where such abandoned motor vehicles, wreckage, junk debris and other materials could be transferred and be removed from public sight and obstructions to vehicular movement;

WHEREAS, the establishment of such Quezon City Junk Yard constitutes a vital and essential component of our beautification and cleanliness program, and the promotion of an ecological environment friendly Quezon City;

WHEREAS, the inventory of fixed assets owned by the Quezon City government includes wide idle lands which could be utilized and made available as the site for the establishment of a Quezon City Junk Yard;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, Quezon City Mayor, Hea. Feliciano R. Belmonte, Jr., to identify from the inventory of fixed assets owned by the Quezon City government, an appropriate government land to be utilized and made available as site for the establishment of Quezon City Junk Yard.
