RESOLUTION NO. SP-161, S 2001

A RESOLUTION RATIFYING THE CONTRACT MADE AND ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT REPRESENTED BY HIS HONOR ISMAEL A. MATHAY, JR., FORMER CITY MAYOR, AS FIRST PARTY, AND RAC PEST CONTROL (RAPECON), REPRESENTED BY ROMEO T. CALOPEZ AND CLARITA R. RIVERA, AS THE SECOND PARTY, FOR PEST CONTROL AND TREATING SERVICE OF THE QUEZON CITY HALL BUILDING.

WHEREAS, after proper negotiations, the Quezon City government represented by the then City Mayor, Ismael A. Mathay, Jr., executed a contract with the RAC Pest Control (RAPECON), represented by Romeo T. Calopez and Clarita R. Rivera, for the treating of the Quezon City Hall building from all forms of pests affecting the building, a copy of the Contract is attached as Annex "A" and shall form part of this resolution;

WHEREAS, the said Contract is to the advantage of the City government as in the long run it will save from its maintenance of the building;

WHEREAS, in his letter of July 19, 2001, the head of the City General Services Office, Mr. Rolando P. Montiel, certified that the RAC Pest Control (RAPECON) has already rendered the contracted service which was the treatment of the Quezon City Hall building against pests such as rats, mice, cockroaches, mosquitoes, flies and other crawling insects, and requested the adoption by the City Council of resolution ratifying the said Contract;

WHEREAS, the said Contract is valid and legal in all respects and may be ratified by the Quezon City Council



NOW, THEREFORE.



PROVIDED, HOWEVER, that all the one (1) year provisions in paragraph IV, V (B) and VI of the Contract shall be change to two (2) years.


