A RESOLUTION URGING THE CITY MAYOR TO DIRECT THE CITY PERSONNEL CITICE TO UNDERTAKE A STUDY ON THE FEASIBILITY OF MAKING THE VARIOUS OFFICES OF THE QUEZON CITY GOVERNMENT AS TRAINING GROUNDS FOR COLLEGE AND VOCATIONAL COURSE GRADUATES WHO ARE RESIDENTS OF QUEZON CITY.

WHEREAS, college graduates who are residents of Quezon City shall be encouraged to be productive while they are looking for work:

WHEREAS, one way of making the situation beneficial to all concerned is to allow the graduates to put into practice the skills and knowledge they learned in school in the various offices of the City government;

WHEREAS, said training is only intended to enrich the work experience of the trainees without expecting to receive any training allowance salary therefrom.

NOW. THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the City Mayor to direct the City Personnel Office to undertake a study on the feasibility of making the various offices of the Quezon City government as training grounds for college and vocational course graduates who are residents of Quezon City, including formulation of the pertinent guidelines therefor.
