
WHEREAS, petitioner, Our Lady of Mt. Carmel Parish, has signified its intention to construct the Our Lady of Assumption Ossuary at a portion of parcel of land located at Road 8 corner Road 2, Project 6, Quezon City, registered in the name of the Roman Catholic Archbishop of Manila;

WHEREAS, in accordance with the provisions of Article VII, Section 2 (c) of Ordinance No. SP-918, S-2000, and its implementing rules and regulations, a special use permit is required for cemeteries to which the proposed project falls under.
