RESOLUTION NO. SP- 1659 "S-2001

A RESOLUTION EXTENDING THE FULL SUPPORT OF THE QUEZON CITY COUNCIL TO THE STRONG SENTIMENT OF HER EXCELLENCY GLORIA MACAPAGAL-ARROYO, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES AGAINST HUMAN CLONING AND FOR HER TO URGE CONGRESS TO PASS A LAW BANNING AND PROHIBITING ANY KIND OF EXPERIMENT ON HUMAN CLONING.

WHEREAS, American scientists have made assertions that it is easier to clone humans;

WHEREAS, cloning is defined as the act of producing asexually a group of organisms from one stock or ancestor;

WHEREAS, not only does cloning contradicts cultural and religious beliefs, but also human morality;

WHEREAS, cloning defies the law or nature and poses a threat to the Circle of Life;


WHEREAS, President Gloria Macapagal-Arroyo has urged Congress to pass a resolution expressing the sentiment of the Filipino people against this new technology, and further stated that the Municipal and City Councils and Provincial Boards should take a stand

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to extend, as it does hereby extend, the full support of the Quezon City Council to the strong sentiment of her Excellency Gloria Macapagal-Arroyo, President of the Republic of the Philippines against human cloning and for her to urge Congress to pass a law banning and prohibiting any kind of experiment on human cloning.

Drilon, Senate President and Congressman Jose De Venecia, Speaker of the House of Representatives, for their Honor's information.
