RESOLUTION NO. SP-1667S-2001

A RESOLUTION REQUESTING HIS HONOR, FELICIANO R. BELMONTE, JR., TO DIRECT THE DEPARTMENT OF PUBLIC ORDER AND SAFETY (DPOS), TO CONDUCT REGULAR AND/OR NIGHTLY PATROL/S AND POST REGULAR OFFICIAL TRAFFIC ENFORCERS ALONG THE MAJOR AND/OR MAIN THOROUGHFARES OF QUEZON CITY SPECIFICALLY ALONG THOROUGHFARES WHERE NIGHTLY "VEHICULAR STREET RACE/S" ARE BEING CONDUCTED FOR THE PURPOSE OF ENSURING EFFECTIVE IMPLEMENTATION AND ENFORCEMENT OF ORDINANCE NO. SP-1013, S-2001.

WHEREAS, the long stretch of the Libis Road which is a part of the Circumferential Road 5 in Quezon City has been made as the regular nightly venue of street racing by irresponsible motorists;


WHEREAS, street racing, whether by cars or motorcycles, or any other kind of vehicle, are not supposed to be undertaken along public roads, streets and thoroughfares of the City;

WHEREAS, under Ordinance No. SP-1013, S-2001, motor vehicle racing within the territorial jurisdiction of Quezon City, using its city streets as speed testing grounds, and providing penalties for violation thereof, is prohibited, amending for the purpose City Ordinance No. 60-4380.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to request, as it does hereby request, His Honor, Feliciano R. Belmonte, Jr., to direct the Department of Public Order and Safety (DPOS), to conduct regular and/or nightly patrol/s and post regular official traffic enforcers along the major and/or main thoroughfares of Quezon City specifically along thoroughfares where nightly "vehicular street race/s" are being conducted for the purpose of ensuring effective implementation and enforcement of Ordinance No. SP-1013, S-2001.
