RESOLUTION NO. SP-1670, S-2001

A RESOLUTION URGING THE HONORABLE CITY MAYOR OF QUEZON CITY TO CONSIDER THE POSSIBILITY OF DISPOSING LOT NO. 4, BLOCK 3, PCS 3424 COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 311477 WITH AN AREA OF TWO THOUSAND FIVE HUNDRED TWENTY-TWO (2,522) SQUARE METERS OWNED BY THE QUEZON CITY GOVERNMENT, LOCATED AT OLD CAMARIN ROAD, ZABARTE, BARANGAY KALIGAYAHAN, QUEZON CITY, IN FAVOR OF THE FIFTY (50) QUALIFIED RESIDENTS/OCCUPANTS THRU THE COMMUNITY MORTGAGE PROGRAM OR THROUGH DIRECT SALE IN ACCORDANCE WITH AND IN THE MANNER PRESCRIBED BY EXISTING LAWS.

WHEREAS, the parcel of land described as Lot No. 4, Block 3, Pcs-3424, containing an area of two thousand five hundred twenty-two (2,522) square meters located at Old Camarin Road, Zabarte, Barangay Kaligayahan, Quezon City, is the property of the Quezon City government;

WHEREAS, the afore-mentioned parcel of land has been occupied openly and continuously since 1960 by several families who have organized themselves into PANGASINAN URBAN POOR ASSOCIATION, INC.;

WHEREAS, the actual occupants are now soliciting the assistance of the City government and the Honorable August Body to implement the land for the landless policy as an initial step in their quest for a decent shelter.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable City Mayor of Quezon City to consider the possibility of disposing Lot No. 4, Block 3, PCS-3424 covered by Transfer Certificate of Title Numbered 311477 with an area of Two Thousand Five Hundred Twenty-Two (2,522) square meters owned by the Quezon City government, located at Old Camarin Road, Zabarte, Barangay Kaligayahan, Quezon City, in favor of


