RESOLUTION NO. SP 1673 S-2001

A RESOLUTION AMENDING SECTION 10 (11), RULE III OF THE RULES OF THE CITY COUNCIL.

Introduced by Councilors **BERNADETTE R. CRUZ-HERRERA, VOLTAIRE GODOFREDO L. LIBAN III, RAMON P. MEDALLA** and **ERIC Z. MEDINA**.

Co-Introduced by Councilors **Franz S. Pumaren, Benedict Wencerom C. Lagumbay, Jesus "Bong C. Suntay, Alma F. Montilla, Antonio E. Inton, Jr., Janet M. Malaya, Restituto B. Malañgen** and **Almario E. Francisco**.

WHEREAS, Section 10 (11), Rule III of the City Council simply provides: "COMMITTEE ON URBAN POOR – All matters relating to the enhancement of the welfare of the less privileged and indigent residents."

WHEREAS, the said Section, as presently worded, is not only too general and equivocal but also fails to include the concomitant subject of "Human Settlement" which under modern concepts of modernization and urbanization should go hand in hand with other problems of the "Urban Poor";

WHEREAS, the welfare of the urban poor must necessarily include logistical, administrative, technical and/or financial support from the city government to enable them to become legal owners of the land where they can be relocated, whether within or outside the territorial limits of Quezon City;

WHEREAS, the specification in the Rules of these added tasks of the proposed Committee on Urban Poor and Human Settlement will provide proper guidance and direction to all concerned;

WHEREAS, to effectuate the desired changes as mentioned in the preceding premises hereof, it has become necessary and urgent to amend Section 10 (11), Rule III of the Rules of the City Council in the manner stated as follows:

"All matters relating to the enhancement of the welfare of the less privileged and indigent residents, including but not limited to logistical, administrative, or financial support to enable urban poor settlers to have a decent place to build their houses on."






