RESOLUTION NO. SP- 1675, S/2001

A RESOLUTION GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO THE FAMILY OF THE LATE PUNONG BARANGAY HERMINIGILDO "GIL" S. MORCO, OF BARANGAY NAYONG KANLURAN, QUEZON CITY, TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 2001 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS THEREFROM.

WHEREAS, Punong Barangay Herminigildo "Gil" S. Morco died on August 15, 2001, at the National Kidney Institute, after his operation for kidney transplant;

WHEREAS, under Ordinance No. SP-223, S-91. "PROVIDING FOR BURIAL BENEFITS FOR BARANGAY OFFICIALS AND REGULAR MEMBERS OF BARANGAY TANOD BRIGADES AND APPROPRIATING NECESSARY FUNDS THEREFOR", the heirs of all deceased Barangay officials, including barangay tanod are entitled to a financial assistance of Thirty Thousand Pesos (P30,000.00);

WHEREAS, at the time of his death, the deceased had served Barangay Nayong Kanluran as Kagawad for seven (7) years and as Punong Barangay for five (5) years;


WHEREAS, the late Punong Barangay Morco had served Barangay Nayong Kanluran and this City faithfully and well whose dedicated services to the community have redounded to the great benefit of the residents thereat which deserve the recognition and appreciation of the City as a whole;

WHEREAS, it is only fitting and proper to grant financial assistance to the surviving members of the family of the deceased.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance in the amount of Thirty Thousand Pesos (P30,000.00) to the family of the late Punong Barangay Herminigildo "Gil" S. Morco, of Barangay Nayong Kaniuran, Quezon City, to be charged against the appropriation for grants, subsidies and contributions in the 2001 Annual Budget of the Office of the City Mayor or from any available funds therefrom.


