RESOLUTION NO. SP-1676, s.2001

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, QUEZON CITY, TO NEGOTIATE UNDER THE SAME TERMS AND CONDITIONS AS FAR AS APPLICABLE AND PRACTICABLE, THE SERVICE CONTRACTS OF EXISTING GARBAGE CONTRACTORS IN THE CITY FROM OCTOBER 1, 2001 TO DECEMBER 31, 2001 PENDING THE PUBLIC BIDDING TO BE CONDUCTED BY THE OFFICE OF THE CITY MAYOR.

WHEREAS, the contract for garbage collection and disposal in the city which was negotiated by the previous administration with the existing garbage hauling contractors expired last June 30, 2001;

WHEREAS, garbage collection and disposal continues to be a perennial problem not only of the city, but of the entire country as a whole;

WHEREAS, the city is expressly mandated under the Local Government Code to deliver basic services related to general hygiene and sanitation to its residents;

WHEREAS, in the interest of the residents of the city, and the public in general, it is advantageous for the present administration to renegotiate and renew, under the same terms and conditions as far as applicable and practicable, pending the public bidding to be conducted by the Office of the City Mayor, the existing contracts with garbage disposal contractors for a period of three months beginning October 2001 and ending December 31, 2001 after which the contracts shall be automatically terminated without the necessity of any further notice.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Feliciano R. Belmonte, Jr., City Mayor, to extend for a period of three (3) months beginning October 1, 2001 until December 31, 2001, under the same terms and conditions, as far as applicable and practicable, the Contracts of Service with the following Garbage Hauling Contractors:



RESOLVED, FURTHERMORE, that during the effectivity of these Service Contracts, the Office of the City Mayor shall conduct a public bidding and award to the winning bidders the contracts for garbage collection.

RESOLVED, FINALLY, that this Resolution shall take effect upon its approval.


