## RESOLUTION NO. SP- $\frac{1677}{1679}$ , S-2001

A RESOLUTION AUTHORIZING THE HONORABLE HERBERT M. BAUTISTA, VICE MAYOR, QUEZON CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY OF THE ACCREDITED CONTRACTORS TO UNDERTAKE THE REHABILITATION, REPAIR AND RENOVATION OF THE OFFICE OF THE CITY COUNCIL SECRETARY LOCATED AT THE 2<sup>ND</sup> AND 3<sup>ED</sup> FLOORS OF THE LEGISLATIVE WING OF THE QUEZON CITY HALL.

WHEREAS, there is an urgent and compelling need to undertake repairs and improvement of the Office of the City Council Secretary located at the 2<sup>nd</sup> and 3<sup>rd</sup> floors of the Legislative Wing of the Quezon City Hall to ensure a more effective and conducive working place for its personnel;

WHEREAS, the City Council Secretary has included in his approved budget appropriation for fiscal year 2001 the amount of Five Hundred Thousand Pesos (Php 500,000.00) for the repair and improvement of his office;

WHEREAS, the work plan and detailed estimate of materials and the cost of project were prepared and approved by the Office of the City Engineer;

WHEREAS, the construction, improvement and renovation of the Office of the City Council Secretary will redound to the benefit of the public in the form of a more efficient service on the part of the public servants of the city.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Herbert M. Bautista, Vice Mayor, representing the City government, to enter into a negotiated contract for the rehabilitation, repair and renovation of the Office of the City Council Secretary located at the 2<sup>nd</sup> and 3<sup>rd</sup> floors of the Legislative Wing of the Quezon City Hall, amounting to Five Hundred Thousand Pesos (P500,000.00) to be taken from the Budget Appropriation of the Office of the City Council Secretary for Fiscal Year 2001.
