RESOLUTION NO. SP- 1679, 2001

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR OF QUEZON CITY, FELICIANO R. BELMONTE JR., TO DISBURSE AND RELEASE PAMASKONG HANDOG FOR CONTRACT OF SERVICE CONTRACTUAL EMPLOYEES AND CONSULTANTS OF THE QUEZON CITY GOVERNMENT FOR THE CHRISTMAS SEASON FROM FUNDS ALLOCATED TO THE MAYOR'S OFFICE, FOR MAINTENANCE AND OTHER OPERATING EXPENSES.

WHEREAS the Quezon City Government presently employs some 1, 500 casual contract of service contractual employees and consultants;

WHEREAS, in view of the present economic condition of the country and the need to spread Christmas cheers to as many persons as possible, there is a need to grant contract of service personnel pamaskong handog cash gifts for the Christmas season.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Mayor of Quezon City, Feliciano R. Belmonte, Jr., to disburse and release Pamaskong Handog for Contract of Service, Contractual Employees and Consultants of the Quezon City government for the Christmas Season from funds allocated to the Mayor's Office for Maintenance and other Operating Expenses, subject to pertinent laws, rules and regulations, according to the following schedule:

Employees on contractual basis who have rendered service as of November 30, 2001 as follows:

<u>Length of Service</u>	<u>Cash Gift Equivalent</u>
Four (4) months or above	P4,000.00
Three (3) months, but less than Four (4) months	P3,000.00
Two (2) months, but less than Three (3) months	P2,000.00
One (1) month, but less than Two (2) months	P1,000.00



Consultants (e), (f), (g) & (h)	8,000.00
Consultants (i), (j) & (k)	6,000.00




