RESOLUTION NO 1683, S-2001

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, QUEZON CITY, TO ENTER INTO A NEGOTIATED CONTRACT FOR THE PUSHING AND LEVELING OF GARBAGE DUMPED AT PAYATAS DUMP SITE, THIS CITY, WITH THE USE OF VARIOUS HEAVY EQUIPMENT DESIGNED THEREFOR TO COVER THE PERIOD FROM JULY 1, 2001 UNTIL DECEMBER 31, 2001 OR EARLIER WHEN A REGULAR PUBLIC BIDDING FOR THE PURPOSE IS CONDUCTED BY THE OFFICE OF THE CITY MAYOR.

WHEREAS, the contract of the pushing and leveling of garbage dumped at Payatas dumpsite, this City, negotiated by the previous administration to heavy equipment operators for the purpose expired last June 30, 2001;

WHEREAS, there is a constant need to level off and push the garbage collected and hauled from various barangays of this City in order to ensure the land stability of the dump site to avoid the occurrence of the tragic land slide that caused the loss of hundreds of lives of scavengers, residents and passers-by at the Payatas Dumpsite;

WHEREAS, the use of appropriate heavy equipment is indispensable in order to attain sound garbage management and likewise to maximize the use of the limited land area duly allocated for the purpose;

WHEREAS, in the interest of the people of Quezon City and the public in general, in order to avoid serious loss of lives and property and similarly to ensure the protection and promotion of a clean and healthy environment, the City government through the Honorable Feliciano R. Belmonte, Jr., do hereby give authority to enter into a negotiated contract for a period of 6 months starting July 1, 2001 until December 31, 2001 or earlier when a public bidding is called upon by the Office of the City Mayor for the purpose or when the public safety and welfare dictates otherwise.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable City Mayor Feliciano R. Belmonte, Jr., to enter into a negotiated contract starting July

1, 2001 until December 31, 2001 or earlier when a public bidding is duly called for the purpose by the Office of the City Mayor or when public safety and welfare dictates otherwise.


RESOLVED, FURTHER, that this resolution shall take effect upon its approval.
