RESOLUTION NO. SP-1584-2001

A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY AND MR. JESS G. DIAZ, CHAIRMAN, AAMES GROUP, A CORPORATION DULY ORGANIZED AND EXISTING UNDER THE LAWS OF THE PHILIPPINES, LAST NOVEMBER 14, 2001, FOR THE INSTALLATION OF CHRISTMAS LANTERNS AND ADVERTISING BANNERS AT THE MERALCO LAMPPOSTS AND THE CITY LAMP WITHOUT COSTS TO THE CITY GOVERNMENT.

WHEREAS, the Quezon City government, represented by the Honorable Feliciano R. Belmonte, Jr., and AAMES Group, represented by chairman Jess G. Diaz, has entered into a Memorandum of Agreement (MOA) last November 14, 2001;

WHEREAS, the MOA is for the installation of Christmas lanterns and advertising banners at the Meralco posts and city owned lampposts on selected streets of the city, the cost of which will be shouldered by the AAMES Group;

WHEREAS, the MOA executed by the City Mayor and AAMES Group must be implemented as soon as possible, due to time constraint, coming this Yuletide Season;

WHEREAS, such move will save the City government for the expenses in decorating its city streets this year and the amount allotted for the purpose may be used for other programs most beneficial to its constituents.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the Memorandum of Agreement entered into by and between the Honorable Feliciano R. Belmonte, Jr., City Mayor, this City and Mr. Jess G. Diaz, Chairman, AAMES Group, a corporation duly organized and existing under the laws of the Philippines, last November 14, 2001, for the installation of Christmas lanterns and advertising banners at the Meralco lampposts and city lampposts in selected thoroughfares and street sidewalks of the city without cost to the city government.

RESOLVED, FURTHER, that the approved Memorandum of Agreement and documents pertaining thereto shall be made an integral part hereof.

RESOLVED, FINALLY, that this Resolution shall take effect upon its approval.
