RESOLUTION NO. 1688, S-2001

A RESOLUTION GRANTING SPECIAL USE PERMIT TO THE CHURCH OF JESUS CHRIST OF THE LATTER DAY SAINTS TO CONSTRUCT A PEDESTRIAN TUNNEL AT TEMPLE DRIVE, GREEN MEADOWS SUBDIVISION, BARANGAY UGONG NORTE.

WHEREAS, the Church of Jesus Christ of Latter Day Saints has formally requested the City Council through the letter of its Area Facilities Manager, Don C. Hala, requesting for a legislative measure that would permit it to construct a pedestrian tunnel across Temple Drive, Green Meadows Subdivision, Barangay Ugong Norte, to "provide a safe and convenient passage for the Church patrons and office workers who often cross the portion of Temple Drive going to and from the office and the Temple;

WHEREAS, the aforesaid request has been favorable indorsed by the Honorable City Mayor, the City Planning and Development Officer, the City Engineer, the Department of Public Works and Highways, the Green Meadows Homeowners Association and the Barangay Ugong Norte Barangay Chairman;

WHEREAS, the proposed pedestrians tunnel will ensure the safety and convenience of the public at large crossing this portion of Temple Drive;


WHEREAS, the construction of the pedestrian tunnel across a privately-owned land will be at no expense to the City.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, a Special Use Permit to the Church of Jesus Christ of the Latter Day Saints for the construction of a pedestrian tunnel across Temple Drive Green Meadows, Barangay Ugong Norte.

RESOLVED, FURTHER, that the construction shall be covered by a Permit from the City Engineer's Office which will also monitor and supervise the construction of the pedestrian tunnel to ensure conformity to laws, rules and regulations specifically on safety standards pertaining to such construction.
