RESOLUTION NO. SP - 1692 , S-2001

A RESOLUTION RATIFYING THE CONTRACT OF PURCHASE ENTERED INTO BY AND BETWEEN THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., QUEZON CITY, AND MR. TEDDY DELA PAZ, GENERAL SALES MANAGER, TOYOTA QUEZON AVENUE, FOR THE ACQUISITION OF TWENTY-THREE (23) UNITS OF TOYOTA TAMARAW FX REVO DLX GAS MOTOR VEHICLES.

WHEREAS, the Quezon City Council has authorized the Honorable Feliciano R. Belmonte, Jr., to enter into a contract of purchase with Toyota Quezon Avenue for the acquisition of twenty-three (23) units of Toyota Tamaraw FX Revo DLX Gas;


WHEREAS, Toyota Quezon Avenue Inc., a corporation established under existing laws, with principal business address at No. 728 Quezon Avenue, Quezon City, is engaged in the business of distribution of motor vehicles, and is willing and able to supply Toyota Tamaraw FX Revo DLX Gas vehicle to the Quezon City government;

WHEREAS, the procurement of twenty-three (23) units of Toyota Tamaraw FX Revo DLX Gas vehicles is covered by sufficient appropriation coming from the Local Government Equalization Fund;

WHEREAS, the required Purchase Order to effect acquisition of the said motor vehicles has already been issued by proper officials of the City government.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the Contract of Purchase entered into by the Honorable Feliciano R. Belmonte, Jr., in behalf of the City government, with Mr. Teddy Dela Paz, General Manager, Toyota Quezon Avenue, for the acquisition of twenty-three (23) units of Toyota Tamaraw FX Revo DLX Gas.




RESOLVED, FURTHER, that the purchase shall be made by way of a duly accomplished Purchase Order.
