RESOLUTION NO. SP- 1694, S-2001

A RESOLUTION GRANTING SPECIAL PERMIT TO GALLERA DE GUISON HERMANOS, INC., (LA LOMA COCKPIT), FOR THE OPERATION OF ITS BUSINESS FOR THE WHOLE CALENDAR YEAR 2002, IN ACCORDANCE WITH EXISTING LAWS, RULES AND REGULATIONS, AND SUBJECT TO THE PAYMENT OF THE CORRESPONDING TAXES, FEES AND OTHER CHARGES THEREFOR.

WHEREAS, the Gallera de Guison Hermanos, Inc., (La Loma Cockpit), established in 1902, has been regularly granted permit to operate its business since 1996, when special permit was granted thereto by virtue of an ordinance introduced by the herein proponent, and its record since its organization speaks well of its fairness in dealing with its clientele;

WHEREAS, the said cockpit holds *pintakasis* three (3) days per week, i.e., every Thursdays, Fridays and Saturdays, or a total of one hundred fifty-six (156) *pintakasis*;

WHEREAS, this grant of special permit to the Gallera de Guison Hermanos, Inc. (La Loma Cockpit), will mean continued remittance of the taxes, fees and other charges being currently remitted by the cockpit to the City government, up to the end of calendar year 2002, without danger to the peace and order situation of the City;



NOW, THEREFORE,


