A RESOLUTION EXTENDING TO HONORABLE JORGE L. BANAL, CTTY COUNCILOR AND PRESIDENT PRO-TEMPORE, THE WARMEST CONGRATULATIONS OF THE PRESIDING OFFICER AND HIS FELLOW MEMBERS IN THE CITY COUNCIL FOR HIS RECENT ELECTION AS CHAIRMAN OF THE METRO MANILA PHILIPPINE COUNCILORS' LEAGUE. (MMPCL).

WHEREAS, in the consensus-election held on Tuesday, November 14, 2001, at the South Villa Restaurant, seventeen councilors from 13 cities and 4 municipalities in Metro Manila unanimously decided on Quezon City Councilor and City Council President Pro Tempore Jorge L. Banal to be the chairman of the Metro Manila Philippine Councilors' League (MMPCL), a decision which was confirmed in a formal election meeting on November 15, 2001 at the Saisaki Restaurant in Mega Mall;

WHEREAS, Councilor Banal's mandate to lead as Chairman of the powerful and influential MMPCL effectively confirms the Quezon City Council's wisdom in appointing him as its official representative to that organization through Resolution No. SP-645, S-2001, as it effectively reinstates Quezon City's leadership in this prestigious aggrupation of Councilors after former Councilor Godofredo T. Liban II. its immediate past chairman, concluded his term as Councilor last June;

WHEREAS. Councilor Banal, by this distinct recent achievement, has brought honor not only to the City Council but to Quezon City as well, even as this latest feather on his cap enhances his long list of accomplishments which has earned him awards, the most recent of which were the Legislator of the Decade and as Hall of Famer in the Bantayog Manuel Luis Quezon Awards.
