RESOLUTION NO. SP- 1701 S- 2001

A RESOLUTION GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30, 000.00) TO BARANGAY KAGAWAD RAYMUNDO S. BARROGA OF BARANGAY STO. NIÑO, DISTRICT IV, QUEZON CITY WHO DIED OF CENTRAL HERNIATION AS A RESULT OF COMPLICATED ILLNESS ON AUGUST 22, 2001, TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2002 ANNUAL BUDGET.

WHEREAS, Barangay Kagawad Raymundo S. Barroga had been one of the staunchest leaders of Barangay Sto. Niño whose dedicated service to his community deserves merit and recognition;

WHEREAS, sometime in 1998, Kagawad Barroga underwent a surgical operation and was hospitalized for more than a month and on August 22, 2001, died due to central herniation;

WHEREAS, there is nothing more appropriate under this circumstance than to grant him financial assistance to defray expenses he and his family had actually incurred during his hospitalization, wake and interment;


NOW, THEREFORE,
