RESOLUTION NO. SP-1702 S-2001

A RESOLUTION URGING THE CITY MAYOR HONORABLE FELICIANO R. BELMONTE, JR., TO CREATE A CHILDREN'S WELFARE FUND FOR ABANDONED, ABUSED AND SEXUALLY EXPLOITED CHILDREN TO BE SOURCED FROM THE SOCIAL WELFARE SERVICES FUND UNDER THE 2002 ANNUAL BUDGET OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, the Quezon City government recognizes its role to defend the rights of the children and to assist and protect them from all forms of abuse and exploitation;

WHEREAS, reported cases of abandoned, abused, and exploited children have steadily increased despite existing laws and policies to protect them;

WHEREAS, these children need special care and attention;


WHEREAS, there is an urgent need to create a Children's Welfare Fund which will exclusively provide the necessary source of funds to establish programs that will rehabilitate abandoned, abused and sexually exploited children.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the City Mayor, Honorable Feliciano R. Belmonte, Jr., to create a Children's Welfare Fund

to be sourced from the social welfare services fund under the 2002 Annual Budget of the City Mayor or from any available funds in the City Treasury.
