RESOLUTION NO. SP. 1710, S-2001

A RESOLUTION REQUESTING THE ELECTRONIC DATA PROCESSING OF THE OFFICE OF THE CITY ACCOUNTANT TO FURNISH THE HONORABLE CITY MAYOR, THE HONORABLE CITY COUNCIL, THE CITY TREASURER AND THE 142 BARANGAY WITH THE UPDATED ACCOUNT OF ANNUAL ADJUSTED REAL ESTATE TAXES IMPOSED AND PAID BY REAL PROPERTY OWNERS OF QUEZON CITY BASED ON THE CURRENT REVISED ASSESSMENTS WITHIN QUEZON CITY AND WITHIN THE JURISDICTION OF EACH BARANGAY PURSUANT TO SECTIONS 232 AND 271 OF R.A. 7160, TO DETERMINE THE RESPECTIVE SHARES OF THE BARANGAY FOR BUDGET PURPOSES.

WHEREAS, the power to levy real estate taxes on land, buildings, machinery and other improvements, which is one of the sources of income and revenue of Quezon City, is defined under Sections 232 and 271 of R.A. 7160, seventy percent (70%) of said taxes will accrue to the city and thirty percent (30%) to the barangays;

WHEREAS, the 142 barangay of Quezon City are not properly informed of the exact amount of real estate taxes accruing to each barangay as basis in the preparation of their annual barangay budget and it has also been observed that uncollected real property taxes have adversely affected the barangay development plans duly approved in the barangay budget due to short real property tax collection as reported by the City Accountant, thus resulting to the non-implementation of duly approved infrastructure projects of the barangay due to lack of available fund.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to request, as it does hereby request, the Electronic Data Processing of the Office of the City Accountant to furnish the Honorable City Mayor, the Honorable members of the City Council, the City Treasurer and the 142 barangays with the updated account of adjusted real estate taxes based on current revised assessments imposed and paid by real property owners within the jurisdiction of each barangay of Quezon City pursuant to Sections 232 and 271 of R.A. 7160 for their information and record in order to determine the share of each barangay for budget purposes.
