RESOLUTION NO. SP-**1711** S-2001

A RESOLUTION URGING THE CITY HEALTH DEPARTMENT AND THE BARANGAY OFFICIALS OF QUEZON CITY, THRU THE BARANGAY HEALTH WORKERS (BHW) AND BARANGAY NUTRITION SCHOLARS (BNS), TO INITIATE PUBLIC AWARENESS AGAINST PNEUMONIA AND OTHER MAJOR CAUSES OF MORTALITY AND MORBIDITY IN QUEZON CITY.

WHEREAS, Article XIII, Section 11 of the 1987 Philippine Constitution provides that:

"The State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged sick, elderly, disabled, women and children. The State shall endeavor to provide free medical care to paupers."

WHEREAS, pneumonia, for the past several years up to the present, has been the leading cause of mortality and morbidity among all ages in Quezon City followed by other major causes;

WHEREAS, the City government that supports the continuous improvement of the delivery of health programs and services focusing on the poor shall develop and conduct effective health and medical information system.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the City Health Department and the Barangay officials of Quezon City, thru the Barangay Health Workers (BHW) and Barangay Nutrition Scholars (BNS), to initiate public awareness against pneumonia and other major causes of mortality and morbidity in Quezon City.






