RESOLUTION NO. SP-1716, S-2002

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR OF QUEZON CITY, TO NEGOTIATE FOR THE EXTENSION OF THE SERVICE CONTRACTS OF EXISTING GARBAGE HAULERS AND HEAVY EQUIPMENT CONTRACTORS IN VARIOUS BARANGAYS OPERATING IN THE CITY UNDER THE SAME TERMS AND CONDITIONS FOR THE PERIOD COVERING JANUARY 1, 2002 TO MARCH 31, 2002, PENDING THE OPENING AND SELECTION OF THE WINNING BIDDERS FOR THE SOLID WASTE COLLECTION AND DISPOSAL AND CLEANING SERVICES UNDERTAKEN BY THE BIDS AND AWARDS COMMITTEE.

WHEREAS, the opening of bids for solid waste collection and disposal and cleaning services has been postponed due to the insistence of the participating bidders for them to be able to comply with all documents and clearances which they signified to submit to the Pre-Qualification, Bids and Awards Committee during the Pre-Bid Conference held last December 10, 2001;


WHEREAS, by reason of such request, the Pre-Qualification, Bids and Awards Committee has decided to reset the opening of bids from December 19, 2001 to January 18, 2002 to give ample time for the bidders to complete the requirements;

WHEREAS, considering the urgency of addressing this perennial problem on waste disposal, the city is mandated under the Local Government Code to provide uninterrupted solid waste collection and disposal services to its constituents and the public in general;

WHEREAS, it is to the advantage and benefit of the city to extend the service contracts of garbage haulers and heavy equipment contractors for another quarter covering the period January 1, 2002 to March 31, 2002, until the Pre-Qualification, Bids and Awards Committee has finally chosen and affirms the winning bidders of the supposed project.










NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Feliciano R. Belmonte, Jr., City Mayor, to negotiate for the extension of the service contracts of existing garbage haulers and heavy equipment contractors in various barangays operating in the city under the same terms and conditions for the period covering January 1, 2002 to March 31, 2002, pending the opening and selection of the winning bidders for the Solid Waste Collection and Disposal and Cleaning Services undertaken by the Pre-Qualification, Bids and Awards Committee of Quezon City.

RESOLVED, FURTHER, that this resolution shall take effect upon its approval.
