RESOLUTION NO. SP- **1720** S-2002

A RESOLUTION DIRECTING ALL BARANGAY COUNCILS TO MAINTAIN A CONTINUING CLEANLINESS PROGRAM IN THEIR RESPECTIVE BARANGAY FOR THIS PURPOSE, TO CLEAN AND UTILIZE VACANT LOTS AND OPEN SPACES UPON PRIOR WRITTEN AND NOTARIZED CONSENT OF THE LOT OWNERS, AS SITES OF LIVELIHOOD PROJECTS.

NOW, THEREFORE.


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to direct, as it does hereby direct, all Barangay Councils in Quezon City to maintain a continuing cleanliness program in their respective barangay.

RESOLVED, FURTHER, to authorize barangay Councils to clean and utilize vacant lots and open spaces within their jurisdiction, upon prior written and notarized consent of the lot owners thereof, as sites of livelihood projects such as the planting of seedlings, vegetables and the like.
