RESOLUTION NO. SP-1727, S-2002

A RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R BELMONTE, JR., TO CREATE A SPECIAL TASK FORCE FOR THE PURPOSE OF MONITORING THE STRICT COMPLIANCE WITH THE BUILDING CODE AND ITS IMPLEMENTING RULES AND REGULATIONS ON SAFETY MEASURES BY THE OWNERS AND OPERATORS OF HOTELS, MOTELS, RESTAURANTS, APARTELLES, OTHER SIMILAR ESTABLISHMENTS AND ALL OTHER COMMERCIAL ESTABLISHMENTS.

WHEREAS, that fateful incident of Manor Hotel in Quezon City which occurred last August 18, 2001, had resulted to the tragic death of more than seventy (70) innocent people;

WHEREAS, it is of public knowledge that not too long ago, an exactly the same incident occurred in this City at Ozone Disco that, likewise, resulted to the untimely death of several persons;

WHEREAS, this City could definitely not afford for the occurrence of another Manor Hotel and Ozone Disco incidents today and in the future, thus, immediate action is unavoidable and indispensable;

WHEREAS, it is a fact that one of the contributory causes of these incidents is the laxity and/or incompetence of certain numbers of City government officials in the strict enforcement of the provisions of the Building Code relative to the safety rules and regulations in these kinds of commercial establishments;

WHEREAS, the creation of a Special Task Force whose duty is mainly to monitor the strict compliance of the above said pertinent provisions of the Building Code in commercial establishments is but timely and an urgent measure to possibly deter such fateful occurences;
