RESOLUTION NO. SP-1730, S-2002

A RESOLUTION DECLARING EVERY FIRST WEEK OF MAY OF EVERY YEAR AS "BARANGAY SECURITY DEVELOPMENT OFFICERS WEEK".

WHEREAS, Section 391, paragraph 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates the organization in the barangay of community brigades, barangay tanod or community service units as may be necessary;

WHEREAS, Section 393 of the same Code provides benefits for barangay tanod such as honoraria, allowances and such other emoluments ~~thereby~~ considering them as indispensable and vital part of the barangay organization;

WHEREAS, the Barangay Security and Development Officers (BSDOs) or popularly known as barangay tanods are carrying great responsibilities such as maintaining peace and order in the Barangay, responding to emergency needs and during calamities serving as quick reaction unit and auxiliary group in delivering relief goods and bringing victims to health centers and hospitals;

WHEREAS, despite of their great role and big responsibility, these barangay tanods are the ones who receive least attention and importance of all the barangay personnel, not because of the nature of their job but may be people may have a wrong impression of their job;

WHEREAS, it is just fair and equitable that this group be given their special day, or week or month to recognize their services to the barangay and most of all create an impression among them that such work is respectable and valuable to every barangay organization.



NOW, THEREFORE,




