RESOLUTION NO. SP-**1734** S-2002

A RESOLUTION STRICTLY URGING FOR THE STRICT IMPLEMENTATION OF A NATIONAL LAW MAKING IT PUNISHABLE FOR ALL ENTITIES OR INDIVIDUALS THE UNAUTHORIZED DESTRUCTION, MUTILATION, IMPAIRMENT OR REMOVAL OF ANY STREET SIGN, TRAFFIC OR OTHERWISE, OR ANY PART THEREOF.

WHEREAS, it has been observed that a lot of street signs within the city have been destroyed, mutilated, or removed by some unscrupulous persons or entities;

WHEREAS, street signs have been put up to help organize the proper flow of traffic and the easy access of people to places within the city;

WHEREAS, these street signs have been put up from valuable resources of the government, hence, should not be dissipated or wasted by reason of the unauthorized removal, destruction, mutilation or impairment of the same, to the prejudice of the people who deserve to be guided thereby;

WHEREAS, a proper and systematic form of instruction such as street signs are desirable and necessary especially in the promotion of Quezon City as a well organized and managed community


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby strictly urge, for the strict implementation of a national law making it punishable for all entities or individuals the unauthorized destruction, mutilation, impairment or removal of any street sign, traffic or otherwise, or any part thereof.
