A RESOLUTION MANIFESTING THE FULL SUPPORT BY THE QUEZON CITY GOVERNMENT, THRU THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR, VICE MAYOR, HONORABLE HERBERT M. BAUTISTA AND THE QUEZON CITY COUNCIL REGARDING PROCLAMATION NO. 135 ISSUED BY HER EXCELLENCY PRESIDENT GLORIA MACAPAGAL-ARROYO AND ADMINISTRATIVE ORDER NO. 71, SERIES OF 2002 ISSUED BY THE DEPARTMENT OF HEALTH SECRETARY MANUEL M. DAYRIT, MD. MSc., PERTAINING TO THE LAUNCHING OF "POLIO-FREE MAINTENANCE IMMUNIZATION CAMPAIGN" THROUGHOUT THE COUNTRY DURING THE MONTHS OF DECEMBER, 2001, FEBRUARY AND MARCH, 2002.

WHEREAS, it is the primary duty of the city government to protect the health of its inhabitants especially if it concerns the health of the children;

WHEREAS, there are three (3) detected cases of recombinant or mutant polio strain in 2001 as a result of high quality Acute Flaccid Paralysis (AFP) Surveillance System, and this recombinant strain can behave like wild polio virus that may cause an outbreak if not given due and immediate attention now;

WHEREAS, the Department of Health will conduct the Door to Door Oral Polio Campaign throughout the country, as well as in the different barangays of Quezon City on February 2 to 8, 2002 (first round) and March 2 to 8, 2002 (second round) in order to flush out any remaining mutant polio strains across the country;

WHEREAS, our city health workers and volunteers will go house to house give Oral Polio Vaccine (OPV) to children age 0-5 regardless of their immunization status to be able to carry out the objective of Polio-Free Maintenance Immunization Campaign;

WHEREAS, in order to succeed in the implementation of this campaign in Quezon City there is a need for the city government to strongly support Proclamation No. 135 issued by Her Excellency President Gloria Macapagal Arroyo and Administrative Order No. 71, Series of 2002 of Department of Health Secretary Manuel M.
