Sabalza, a former Undersecretary of the Department of Transportation and Communication (DOTC) and Head of the Land Transportation Office (LTO), best suited to be appointed and to discharge the function of the Department Head of the Department of Public Order and Safety of Quezon City;

WHEREAS, Mr. Sabalza, aside from his vast experiences and track record in the public service, have already proven his capacity and dedication, as shown by his accomplishments since appointed Head of the DPOS;


WHEREAS, above mentioned position is co-terminus with the appointing authority pursuant to Ordinance No. NC-140, S-90, which created the department and its personnel complement,

NOW, THEREFORE,




