RESOLUTION NO. SP- **1740** S-2002

A RESOLUTION AUTHORIZING THE SANGGUNIANG BARANGAY OF KRUS NA LIGAS, THIS CITY, TO USE THEIR 2001 CALAMITY FUND BUDGET AMOUNTING TO TWO HUNDRED THIRTY THOUSAND PESOS (P230,000.00) FOR THE PURCHASE OF THE NEEDED SULFAC SPRAY CHEMICAL SOLUTION USED IN ERADICATING AND CONTROLLING THE DREADED MOSQUITO CARRYING DENGUE DISEASE IN THEIR BARANGAY.

WHEREAS, the depressed areas of Barangay Krus na Ligas, District IV, this City, has been the most affected area in terms of mosquito borne disease;

WHEREAS, there is a dire need for the barangay to purchase the Sulfac Spray Chemical Solution, known to possess larvicidal properties and is proven effective and adviceable than the other leading chemicals used in the fogging and fumigation activities conducted for the eradication of dengue carrying mosquitoes;

WHEREAS, the Barangay Council of Krus na Ligas had approved Barangay Resolution No. 90-S-2001, urgently requesting the Quezon City Council to allow them to use their 2001 Calamity Fund Budget needed in their campaign for eradication and exterminating the dengue carrying mosquitoes and its breeding places;

WHEREAS, number of dengue cases have been reported in the barangay, which up to the present has been plaguing its depressed areas;


WHEREAS, the health and safety of our inhabitants being the primary concern of the city government, must heed to the call made by the barangay residents through their barangay officials to fight the formidable disease called "dengue fever", brought by this water bred mosquitoes.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Sangguniang Barangay of Krus na Ligas, this City, to use their 2001 Calamity Fund Budget amounting to Two Hundred Thirty Thousand Pesos (P230,000.00) for the purchase of the needed sulfac spray chemical solution used in eradicating and controlling the dreaded mosquito carrying dengue disease in their barangay.

RESOLVED, FURTHER, that the community shall organize and conduct information and education campaigns on individual household cleanliness to eradicate the possible breeding sites of mosquitoes.




