RESOLUTION NO. 1744, S-2002

A RESOLUTION STRONGLY URGING THE CHAIRMAN OF THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY (MMDA) AND THE SECRETARY OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) TO INSTALL ADEQUATE TRAFFIC LIGHTS AND SIGNS AT THE CORNER OF QUIRINO AVENUE AND ASCENCION ROAD, INTERSECTION OF MINDANAO AND REGALADO AVENUES, AND REGALADO AVENUE CORNER BRISTOL STREET, ALL OF BARANGAY GREATER LAGRO, QUEZON CITY.

WHEREAS, traffic congestion is being experienced at the vicinity of SM Fairview especially during rush hours, and of the other business establishments at Quirino, Regalado and Mindanao Avenues;

WHEREAS, the stretch of Quirino, Regalado and Mindanao Avenues are being utilized by motorists as alternate routes going to Malabon, Navotas, Bulacan and other provinces in Central Luzon, thereby accumulating large volume of vehicles;

WHEREAS, due to lack of adequate traffic lights or signs existing at the intersections along Quirino, Regalado and Mindanao Avenues, vehicular accidents oftentimes occur resulting to the death of innocent persons and damage to properties;

WHEREAS, the Punong Barangay of Barangay Greater Lagro, Hon. Manuel C. Tolentino, in his letter of July 4, 2001 stressed the need for the installation of traffic lights and signs in the aforesaid avenues and road intersections.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby strongly urge, the Chairman of the Metropolitan Manila Development Authority (MMDA) and the Secretary of the Department of Public Works and Highways (DPWH) to install adequate traffic lights and signs at the corner of Quirino Avenue and Ascencion Road, intersection of Mindanao and Regalado Avenues and Regalado Avenue corner Bristol Street, all of Barangay Greater Lagro, Quezon City.

RESOLVED, FURTHER, that copies of this resolution be forwarded to the Metropolitan Manila Development Authority and Department of Public Works and Highways for their information and appropriate action.
