RESOLUTION NO. SP- 1745, s- 2002

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH LOT 21, BLOCK 17 OLD TENANTS ASSOCIATION INCORPORATED, BARANGAY BUNGAD, DISTRICT I, QUEZON CITY, FOR THE IMPROVEMENT OF THE DRAINAGE OF THE SAID ASSOCIATION SITE AS PART OF THE COMMUNITY DEVELOPMENT PROJECTS OF THE CITY GOVERNMENT AND URGING/AUTHORIZING THE RELEASE OF THE AMOUNT OF TWO HUNDRED SEVENTY FIVE THOUSAND THREE HUNDRED FORTY SEVEN PESOS (P275,347.00) THEREFOR.

WHEREAS, there is a need to put up a proper drainage system to be used by the residents of Barangay Bungad particularly Lot 21, Block 17, San Francisco Del Monte, District I, Quezon City;

WHEREAS, the Old Tenants Association, Inc. had signified their willingness to undertake the actual work on the construction of the abovementioned drainage project, provide safety measures around the construction site while work is on-going, and secure the materials for the subject project with appropriate diligence under a memorandum of agreement hereto attached;


WHEREAS, there is already a Request for Obligation Allotment for the said project in the amount of P275,347.00.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable City Mayor, to enter into a Memorandum of Agreement with Lot 21, Block 17 Old Tenants Association Incorporated, Barangay Bungad, District I, Quezon City, for the improvement of the drainage of the said association site as part of the Community Development Projects of the City government and to strongly urge the Office of the City Mayor to release the amount of Two Hundred Seventy Five Thousand Three Hundred Forty Seven Pesos (P275,347.00) already allocated therefor.
