RESOLUTION NO. SP 1748, S-2002

A RESOLUTION URGING THE LEADERSHIP OF BOTH HOUSES OF CONGRESS TO IMMEDIATELY APPROVE THE PASSAGE OF HOUSE BILL NO. 3914 ENTITLED "AN ACT THAT WOULD ESTABLISH A MAGNA CARTA FOR BARANGAYS."

WHEREAS, being the basic political unit in our society, the barangay serves as the preliminary planning and implementing unit of government programs, projects and activities;

WHEREAS, recognizing the important role of the barangay in serving as a forum in the expression of the collective views of the people, several laws were enacted to strengthen their existence and define their powers and duties;

WHEREAS, notwithstanding the awesome responsibilities reposed on the barangay government, the existing laws empowering the barangay remain inadequate;

WHEREAS, due to the foregoing consideration, the approval of House Bill 3914 will certainly promote the welfare and prosperity of the barangay.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the leadership of both Houses of Congress to immediately approve the passage of House Bill No. 3914 that would establish the Magna Carta for Barangays.
