RESOLUTION NO. SP-**1751**, S-2002

A RESOLUTION URGING BUSINESS ESTABLISHMENTS USING ORIGINAL COMPOSITIONS TO COMPLY WITH R.A. NO. 8293, OTHERWISE KNOWN AS THE "INTELLECTUAL PROPERTY CODE OF THE PHILIPPINES".

WHEREAS, there is a need to rectify the unauthorized use by business establishments of copyrighted music in their premises;

WHEREAS, musical compositions are being performed publicly or communicated within the territorial boundaries or jurisdiction of Quezon City without the permission of the composers as provided for in Republic Act No. 8293;

WHEREAS, R.A. No. 8293, otherwise known as the "Intellectual Property Code of the Philippines," prescribes for the exclusive copyrights and economic rights of composers;

WHEREAS, the Republic of the Philippines recognizes the vital role of artists in nation building.




NOW, THEREFORE,


