A RESOLUTION ALLOCATING THE AMOUNT OF NINE HUNDRED FORTY-EIGHT THOUSAND SIX HUNDRED THIRTY FOUR PESOS AND NINETY FIVE CENTAVOS (P948, 634.95) FOR THE CONSTRUCTION OF JOAN OF ARC FOOTBRIDGE AND RIPRAPING OF CERTAIN PORTION OF TULLAHAN RIVER BOTH LOCATED IN BARANGAY GULOD, QUEZON CITY.

WHEREAS, the Joan of Arc bridge serves as a main and strategic passage for the residence of Barangay Gulod in going to and from the different areas in Metro Manila;

WHEREAS, the Joan of Arc Bridge located at Barangay Gulod Novaliches, Quezon City was heavily damaged by a recent strong typhoon;

WHEREAS, it is the duty of the City Government to provide its constituents with basic and essential services including infrastructure projects necessary in their everyday task;

WHEREAS, the Barangay Council of Barangay Gulod had already signified the urgency of constructing the Joan of Arc footbridge and the riprapping of certain portions of Tullahan River, through this humble representation to ensure their safety and well being.

NOW, THEREFORE;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to allocate, as it does hereby allocate, the amount of Nine Hundred Forty-Eight Thousand Six Hundred Thirty-Four Pesos and Ninety Five Centavos (P948, 634.95) for the construction of Joan of Arc footbridge and riprapping of certain portion of Tullahan River both located in Barangay Gulod, Novaliches, Quezon City.


