RESOLUTION NO. SP-1761 ¹_{S-2002}

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, QUEZON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT IN BEHALF OF THE CITY GOVERNMENT, WITH THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION, METRO MANILA DEVELOPMENT AUTHORITY, PHILIPPINE NATIONAL POLICE AND THE CITY GOVERNMENT OF MAKATI, MANDALUYONG, PASAY AND CALOOCAN, FOR THE CONSTRUCTION, OPERATION AND MAINTENANCE OF PUBLIC TOILETS IN STRATEGIC LOCATIONS ALONG MAJOR THOROUGHFARES IN METRO MANILA.

WHEREAS, the City Council of Quezon City must signify its affirmation of such a laudable and noteworthy endeavor by authorizing the Honorable Mayor Feliciano R. Belmonte, Jr. to enter into the necessary contracts and agreements to make this project a reality;




NOW, THEREFORE,


