A RESOLUTION URGING HIS HONOR, CITY MAYOR FELICIANO BELMONTE, JR., TO REQUIRE BARANGAY TANODS IN QUEZON CITY TO UNDERGO TRAINING AT THE METRO MANILA DEVELOPMENT AUTHORITY (MMDA) TRAFFIC MANAGEMENT OFFICE FOR THEIR ULTIMATE DEPUTIZATION AS TRAFFIC ENFORCERS.


WHEREAS, the MMDA has expressed its willingness to train Quezon City Barangay Tanods.
