A RESOLUTION STRONGLY URGING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, TO ESTABLISH A TAX FRAUD UNIT UNDER THE DIRECT SUPERVISION AND CONTROL OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, there have been reports of cheating and deception in the payment of taxes imposed by the city government possibly with the connivance of employees of city agencies involved in the computation and/or collection of taxes;

WHEREAS, considering that most taxes are paid in the month of January, there is an immediate need to establish at this time a unit which shall prevent the commission of tax frauds which deprive the city treasury of substantial amount of revenue;

WHEREAS, the tax fraud unit should be under the direct control and supervision of an office which is not involved in the preparation of tax documents and which has the authority to investigate irregularities in the city government;

NOW, THEREFORE

BE IT RESOLVED BY CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby strongly urge, the Honorable Feliciano R. Belmonte, Jr., City Mayor to immediately establish a Tax Fraud Unit under the direct control and supervision of the Office of the City Mayor.


