RESOLUTION NO. SP **1771**, S-2002

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO, R. BELMONTE, JR., CITY MAYOR, THIS CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY REPUTABLE AND QUEZON CITY ACCREDITED CONSTRUCTION CORPORATION FOR THE CONSTRUCTION OF A PEDESTRIAN OVERPASS AT COMMONWEALTH AVENUE, INFRONT OF COMMONWEALTH PUBLIC MARKET, BARANGAY COMMONWEALTH, DISTRICT II, QUEZON CITY.

WHEREAS, Sec. 16 of R.A. 7160, otherwise known as the Local Government Code of 1991, provides, to wit, "Every local government unit shall exercise the powers expressly granted xxx as well as powers necessary to xxx, promote health and safety, xxx and preserve the comfort and convenience of their inhabitants" (emphasis provided):

WHEREAS, there are number of reported cases of road accidents involving pedestrians along Commonwealth Avenue, District II, this city, in front of Commonwealth Public Market;

WHEREAS, these related road accidents need to be addressed by the city government, to prevent the unnecessary loss of lives among its constituents;

WHEREAS, for this purpose, the city government is seriously considering the plan to construct a pedestrian overpass along Commonwealth Avenue for the best interest of the city and the public in general;

WHEREAS, the City Mayor is hereby given the authority to enter into a negotiated contract with any reputable and city accredited construction corporation for the construction of the pedestrian overpass along Commonwealth Avenue, in front of Commonwealth Public Market.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY, IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Feliciano R. Belmonte, Jr., to enter into a negotiated contract with any reputable and Quezon City accredited construction corporation for the construction of a pedestrian overpass along Commonwealth Avenue, in front of Commonwealth Public Market, Barangay Commonwealth, District II, Quezon City.

RESOLVED, FURTHER, that the construction firm chosen must be confirmed by the City Council together with the contract entered into,
