RESOLUTION NO. SP-17722002

A RESOLUTION GRANTING BURIAL ASSISTANCE TO THE FAMILY OF KAGAWAD REYNALDO SALVADOR OF TEACHER'S VILLAGE EAST, 4TH DISTRICT, WHO DIED IN THE PERFORMANCE OF HIS OFFICIAL DUTY, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO BE TAKEN FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.


WHEREAS, Reynaldo A. Salvador has been one of the staunchest kagawad of Barangay Teachers Village East from 1988 to 2002 whose dedicated service to his community deserve merit and recognition;

WHEREAS, on the dawn of February 7, 2002, Kagawad Salvador, while in the performance of his official duties, died in a tragic and fatal vehicular accident;

WHEREAS, there is nothing more appropriate under the circumstances than to grant him a financial assistance to defray expenses for his burial and other expenses his family had actually incurred during his wake and interment;

WHEREAS, the City Government through Ordinance No. NC-233, S-91, explicitly provides for burial benefits for barangay officials who died in line of duty.







NOW, THEREFORE,


